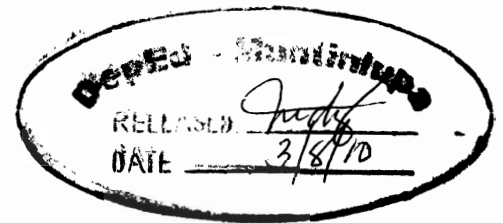

The Acceptance of application shall be on FIRST COME FIRST-SERVED basis. Applications may no longer be accepted before the deadline if there are already enough number of applicants.

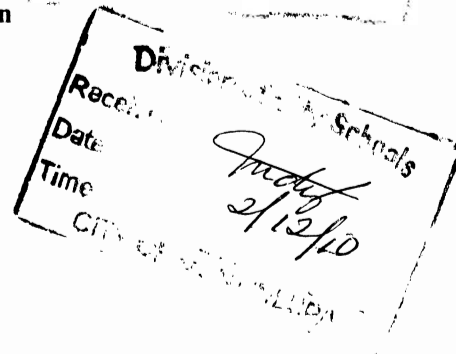
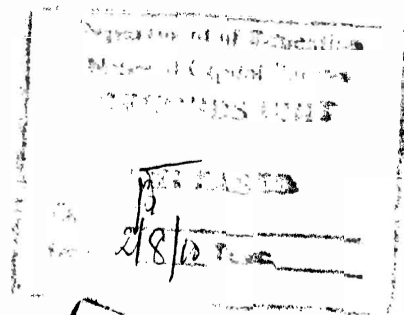
